Additionally, a three-year strategic plan was developed and approved. Five strategic goals were identified, directing our work to:

- ENSURE data-driven decision-making across all prevention initiatives
- SUPPORT community engagement
- IMPLEMENT evidence-based prevention by building and strengthening capacity across community sectors
- INCREASE prevention system infrastructure by providing training, technical assistance, and mentoring through the PF! TrainingHUB!
- GROW organizational resources

During FY21, PreventionFIRST! was positioned and ready to play an important role in helping youth and families move beyond the pandemic. Significant investments in prevention funding provided additional resources for PreventionFIRST! This funding allowed the organization to strengthen partnerships for both substance abuse and mental health promotion including implementing the Sources of Strength program, implementing the Rise and Thrive Initiative focused on improving the health of students, faculty, and staff on Ohio campuses of higher education, and assisting Hamilton County school districts in implementing student wellness and success initiatives.

PreventionFIRST! remains dedicated to supporting effective prevention efforts — from individual classrooms to entire school districts, from a group of concerned parents to community coalitions, from the college graduate to the certified prevention specialist. 

CENTER FOR COMMUNITY ENGAGEMENT

In FY21, there were thirty PF! member coalitions representing suburban, urban and rural communities. PF! and its member coalitions are also members of the Community Anti-Drug Coalitions of America (CADCA). Ohio-based coalitions are also members of the Ohio Statewide Prevention Coalition Association (SPCA).

COALITION ACADEMY

Approximately 1,300 individuals from across the country attended this virtual, two-day conference. This year's theme was "A Pivotal Year for Prioritizing Prevention & Wellness." Funding was provided from the Hamilton County Mental Health and Recovery Services Board and the Ohio Department of Mental Health and Addiction Services.

SPRING MEMBERSHIP MEETING

An annual training event for PF! member coalitions to build skills, network and share resources about effective prevention strategies. This year focused how to engage youth in a virtual world, how to engage hard to reach community sectors, and how to apply graphic design basics to coalition marketing.

HAMILTON COUNTY ADDICTION RESPONSE COALITION: African American Engagement Work Group (AAEWG)

As a coalition and work group member, PF! provided 120 individuals with prevention trainings, services, or technical assistance to help reduce opioid use/misuse and fentanyl use in Hamilton County African American communities.

BUILDING PREVENTION WITH FAITH

Grant funding from the Ohio Governor's Office of Faith-Based and Community Initiatives fostered partnerships between non-profit organizations and more than 850 members of faith-based communities. The goal of the funding was to reduce the stigma of substance use disorders and mental illness. PF!'s Building Prevention with Faith toolkit was the approach used to introduce Ohio faith communities to evidence-based prevention strategies, reduce stigma and provide resources.

CENTER FOR **PREVENTION ACTION**

TRAINING AND SUPPORT

- Partnering with the Hamilton County Educational Service Center (ESC), PF! provided a three-module training designed to help educators and administrators implement high quality, comprehensive prevention in schools.
- Held two virtual youth summits provided an opportunity for high school students to learn and apply healthy coping strategies during the pandemic.
- PF! along with Cincinnati Children's Hospital Medical Center, Hamilton County Public Health, and Talbert House provided opioid outreach and education to churches in Hamilton County. Participants then implemented prevention practices, strategies, and standards in their ministries.
- In partnership with the OCAM (Ohio Coaching and Mentoring) Network, 3856 individuals attended virtual trainings or received coaching services. This initiative provides capacity building and workforce development for prevention professionals and is funded by OhioMHAS.
- In FY21, OCAM was awarded the ADAPAO, Organization of the Year Award for exemplary efforts in advancing the mission of ADAPAO. ADAPAO is a membership-based, not-for-profit association that serves as the voice of prevention in Ohio, with a specific focus on preventing substance use and mental disorders.

PUBLIC AWARENESS

This year several radio, television, digital, and social media buys generated over \$1,395,970 media impressions for PF! Messaging promoted: general behavioral health awareness, community engagement, coalition development, and faith-based resources focused substance use disorder and/or mental illness.

CENTER FOR PREVENTION SCIENCE

Coalition Evaluation Center

The Coalition Evaluation Center (CEC) provides local evaluation services to community coalitions. An online system is used to track accomplishments. Data from this system helps PF! and participating coalitions track community level changes related to youth substance use/misuse. During FY21 the system was utilized by PF! and Stavin' Alive (Franklin County, Indiana)

Student Survey

The PF! Student Survey, administered every two years, helps us understand the scope of substance use, attitudes about substance use, and identify the strengths and gaps of existing policies/programs in schools and communities. Recruitment for the twelfth survey cycle began in FY21.

Strategic Prevention Framework for Prescription Drugs (SPF Rx)

This initiative provides resources to help prevent and address prescription drug misuse throughout Ohio. During FY21, PreventionFIRST!:

- Mailed 163 drug disposal pouches to Ohio residents.
- Partnered with the Alcohol and Drug Abuse Prevention Association of Ohio (ADAPAO) and Ohio University to support eighteen individuals in advancing their prevention professional credentials.
- Raised awareness of the expansion of Ohio's Good Samaritan Law to include drug overdose by distributing 1,000 bags with health/safety related supplies and related information.
- Advanced PF! recognition in Greater Cincinnati Hispanic/Latino communities with a radio media buy serving the Spanish speaking listening market.
