General Assembly Life Cycle

- New General Assembly Every 2 years
- Currently near the end of the 133rd General Assembly
- Legislation needs to be reintroduced every General Assembly
- Biennium Budget completed in the spring/summer of 1st year
- Capital Budget typically completed by the start of 2nd year























Office of the Legislative Inspector General

The OLIG is the ethics advisory office to Ohio's legislative branch of government. Through the Joint Legislative Ethics Committee, it provides ethics, conflict of interest, and financial disclosure guidance to members and employees of the general assembly, candidates for the general assembly, and the employees of the state's legislative agencies.












*Internal Revenue Service (IRS)

The Internal Revenue Service (IRS) administers the federal tax laws that Congress enacts. The IRS performs three main functions—tax return processing, taxpayer service, and enforcement. In addition, the IRS conducts criminal investigations and oversees tax-exempt organizations and qualified retirement plans.









Advocacy (Merriam-Webster Definition)

The act or process of supporting a cause or proposal

Advocacy (CADCA Definition)

Doing whatever you can to educate people on your position

Lobbying (OLIG Definition)

Attempting to influence a lawmaker, executive agency or retirement system decision-maker on a public policy matter


Lobbying (CADCA Definition)

Taking a specific position on a specific piece of legislation



- Compensated to advocate the interests of another
- Lobbyist Categories: legislative agents, executive agency lobbyists, or retirement system lobbyists.
- If attempting to influence legislation, categorized as a legislative agent
- Lobbyists are often both legislative agents and executive agency lobbyists.









Office of the Legislative Inspector General

Lobbying does not include any of the following

- Grassroots efforts.
- Contacts made for the sole purpose of gathering information contained in a public record.
- · Appearances before public hearings.
- News, editorial, etc.
- Publications primarily designed for and distributed to members of bona fide associations, or charitable or fraternal nonprofit corporations.










1. **Compensation:** The lobbyist must receive compensation for conducting lobbying activity









2. Direct communication: The lobbyist must directly

communicate with a reportable person









Who is a Legislative Reportable Person?

- Any member of the general assembly or controlling board.
- The head of any department or agency listed in Appendix C (Ohio Lobbying Handbook
 p. 93)
- Any legislative staff listed in Appendix D (Ohio Lobbying Handbook p. 95)
- The Governor
- Any staff of the governor or department listed in Appendix C who is required to file a financial disclosure statement.

- 3. Amount of compensated time lobbying by employer:
 - Legislative Lobbying: 5%
 - Executive Agency Lobbying: 25%
 - Retirement System Lobbying: 25%










Lobbying Snapshot: Indiana

- Regulatory Agency: Indiana Lobby Registration Commission (ILRC)
- Lobbyist Defined. Under IC 2-7-1-10, a "lobbyist" is a person who"
 - (1) engages in lobbying; and
 - (2) in any registration year, receives or expends an aggregate of at least five hundred dollars (\$500) in compensation or expenditures reportable under IC 2-7 for lobbying, whether the compensation or expenditure is solely for lobbying or the lobbying is incidental to that person's regular employment.
- "Unless one meets both tests, registration is not required."

Lobbying Snapshot: Kentucky

- Regulatory Agency: Kentucky Legislative Ethics Commission
- Legislative Lobbying "to promote, advocate, or oppose the passage, modification, defeat, or executive approval or veto of any legislation [or administrative regulations] by direct communication with any member of the General Assembly, the Governor, the secretary of any cabinet listed in KRS 12.250, or any member of the staff of any of the officials listed in this paragraph." KRS 6.611(26)(a).
- Each calendar year that a person qualifies as a Legislative Agent, the Legislative Agents and his or her employer must register with the KLEC.












- Strategies to avoid issues
 - Avoid compensation
 - Communicate with officials off the clock
 - Talk about issues not bills
 - Work through an association or a firm
 - Testify on legislation to voice complaints
 - Communicate on behalf of yourself as a constituent
 - Do not use federal funds or grant funding

- Amendments Any alteration made (or proposed to be made) to a bill or clause by adding, deleting, substituting, or omitting.
- Committee Chair Highest position on a committee usually held by a member of the majority party. Sets schedule for committee hearing and decides what bill will be heard.
- Conference Committee Members from both chambers that come together to work out the differences between the House and Senate versions of a bill.
- Committee Vice Chair Supports the Chair, will take over in case of Chair's absence
- Continued hearings on measure will continue
- · Interested Party interested only, not in favor nor against
- Legislative Aide (In House and Senate) Aide to a Senator or Representative. Responsible for half or all of the office functions including but not limited to committee functions, stakeholder relations, constituent relations and administrative tasks.

- Legislative Services Commission Legal arm of the legislature. Responsible for writing the official language for all bills, commendations and resolutions. Also responsible for research upon request.
- **Measure** General term for bill, resolution or memorial.
- Opponent those against
- Proponent those in favor
- Ranking Member Lead committee member for minority party. Responsible for advocating on behalf of the minority party's interests and stances
- Reported Action by a committee on a measure which moves the measure out of the committee. A measure may be reported out with a do pass, do not pass, amend, substitute, refer to another committee, or no recommendation.
- Senior Legislative Aide (only in Senate) Head aide to the Senator mainly responsible for committee functions, stakeholder relations, constituent relations and administrative tasks. Responsibility is shared with the Legislative Aide
- Substituted the substitute replaces the original bill or resolution.
