## Sequoia Ballroom 3 What Keeps Prevention From Being First?



#### O'DELL MORENO OWENS, MD, MPH

Today's keynote address will increase your understanding of the factors that impact prevention work. These factors include cultural competency, environmental factors, epigenetics, and health literacy.

Primary prevention can only truly be implemented when the community is fully educated to the issues and is inspired to participate in making neighborhoods better. Not having a clear understanding of the cultural and health disparity of

a community only lessens the impact of any prevention effort.

The importance of consistent use of cultural competency concepts in marketing as well as organization culture will also be addressed.

#### Keynote Objectives

- Attendees will learn prevention science on substance use disorders, behavioral health disorders, physical health and safety.
- Attendees will be able to identify risk and protective factors, developmental stages and adverse childhood experiences.
- Attendees will learn how to link data to research and prevention strategies.

Dr. O'dell Owens is the current CEO/President of Interact for Health. He holds both an MD and a Master's of Public Health from Yale University Medical School. Owens completed a fellowship in reproductive endocrinology at Harvard Medical School and served as a clinical instructor in reproductive endocrinology. After returning to his native Cincinnati in 1982, Owens established an in-vitro fertilization program at the University of Cincinnati Medical Center. He achieved Cincinnati's first successful conception and delivery as well as the first pregnancy from a frozen embryo.

In recent years, Dr. Owens has served as the Hamilton County Coroner, Cincinnati State Technical and Community College President and Medical Director/Interim Health Commissioner of the Cincinnati Health Department. Dr. Owens is currently on the board of the Cincinnati Fire Foundation, the Carl H. Lindner Jr. Family Center for Conservation and Research of Endangered Wildlife (CREW) at the Cincinnati Zoo and Cincinnati Preschool Promise; and is the longest-tenured member and former lead director of the U.S. Bancorp Board of Directors. He previously served as Chair of the University of Cincinnati Board of Trustees and City of Cincinnati Board of Health.

It will provide an overview of the cultural competence continuum including cultural humility. The session will also offer practical strategies in terms of engaging diverse stakeholders and building inclusive coalition cultures. This session will also outline how diverse perspectives can enhance current work and lead to improved coalition effectiveness and social change.

- Attendees will explain cultural competence as a framework to strengthen capacity building.
- Attendees will describe the continuum of cultural competence.
- Attendees will outline strategies for building inclusive coalition cultures.

#### Sequoia Ballroom 3 Boone County Alliance: Highlights of Community Change

Abby Beausir, Drug Free Communities Grant Coordinator/Health Educator

**Description:** This workshop will cover community change strategies to reduce youth access to alcohol through online grocery pick up services in Boone County, Kentucky. A survey was conducted by the Boone County Alliance, and this session will go over the methodology, intervention, and results of the survey. The concern of youth access to alcohol through online grocery pick up services (i.e. Kroger Click List or Pick Up) was brought to the coalition's attention. The goal of this project is to increase compliance with checking identification when alcohol is purchased through the online service and improve policies at grocery stores offering online pick up services.

- Attendees will demonstrate a better understanding of how primary prevention is an integral part of youth behavioral health.
- Attendees will develop skills and utilize tools at the community-level for behavioral health issues.
- Attendees will be able to identify both risk and protective factors for primary and secondary prevention strategies.

# Sequoia Ballroom 4 HEAD GAMES: A Look at the Ultimate Gamble

Cheryl Mahoney, M.Ed., LSW, iWise Living

**Description:** With the World Health Organization including Gaming Disorder in the ICD 11, prevention professionals and/or coalition volunteers need to be ready to add problematic gaming and Internet gambling to their repertoire. In this session, we'll take a look at what's going on, how it could be affecting youth and what professionals and caregivers can do to make a positive difference.

#### Learning Objectives:

- Attendees will be able to identify the pervasiveness of gambling within video games and understand biochemical responses that lead to disordered gaming and gambling.
- Attendees will be able to discuss ways players are using gaming to meet social and emotional needs through participation.
- Attendees will be able to identify common industry practices used to manipulate consumers and understand how free games like Fortnite can bring in \$300 million a month.

# Universal Screening in Schools for Mental Health and Substance Use

**Cricket Meehan**, PhD, Director, Miami University Center for School-Based Mental Health Programs **Deb Robison**, MA, LSW, Project Coordinator, Miami University Center for School-Based Mental Health Programs

**Description:** Universal screening is a model widely used in schools to assess and provide early intervention for academic concerns. Using this same model can yield similar outcomes when applied to screening for mental health conditions and substance use/misuse. Screening and early intervention can support home and school success. This session will review several screening tools for both mental health and SBIRT (Screening Brief Intervention and Referral to Treatment) for substance use/misuse, discuss the obstacles to offering universal screening tools. Participants will leave this session with both a toolkit (screening tools and resources for supporting students identified with mental health and substance use concerns) and an action plan for implementation of universal screening within schools served by their coalition.

- Attendees will understand the role of universal screening in assessing and providing early intervention for mental health conditions and substance use.
- Attendees will understand how to choose an appropriate screening tool to meet the needs of the population they serve.
- Attendees will utilize their toolkit in developing an action plan for implementation of universal screening within schools.

## Passing the Baton: Successful Succession Planning for Local Coalitions

**Description**: Coalition building, including infrastructure and capacity development, is hard work. True grassroots community change requires an "all hands on deck" approach, whereby sustainability is often discussed in terms of funding and programming resources. While many are asking "how will you sustain your work financially?," our biggest challenge and focus was in identifying leadership. As our coalition transitioned from one phase to the next, we found ourselves asking questions like, "What happens when the leader leaves? Will the whole coalition fall apart? Will the priorities remain the same? How does a community successfully move from one leadership style to another?" Join us in a discussion on the hurdles we faced and our lessons learned in the "passing of the baton" in a local coalition. You can begin to think about your own coalition's long-term leadership plan and develop a succession strategy to ensure your good work continues and withstands change.

- Attendees will understand how succession planning is a component of coalition sustainability.
- Attendees will learn to conduct a gap analysis of their organization.
- Attendees will begin to develop a plan for leadership succession within their coalition.

**Description**: Just because most adults already have established relationships with alcohol and other drugs, doesn't mean it's too late for substance use/misuse prevention strategies. Since many adults are employed, the workplace is a prime location to reach them. We will look at alcohol and other drug (AoD) issues through the lens of the workplace, explore best-practice drug-free workplace strategies along the continuum of care, and showcase environmental strategies targeting the workplace.

- Attendees will learn how to identify prevention strategies targeting the workplace.

**Description:** Marketing and social media play important roles in celebrating your coalition's successes, sustaining member/partner engagement, and promoting the six prevention strategies. We may recognize the value of marketing/social media, but often lack the time, money, people power, and understanding to fully commit to these tactics. This session will provide tips, tricks, and templates to help navigate these barriers. Participants will get an overview of social media platforms, tips on targeting audiences, and tricks on how to create engaging content. Additionally, attendees will learn how to develop and implement effective and manageable marketing plans. Part of the session will be dedicated to practice social media skills and draft mini marketing plans.

### THC vs. CBD: What's the Difference and Does it Matter?

Alysha Behrman, RN, MSN, CSPI, OCPSII, ICPS, Cincinnati Children's Hospital Medical Center

**Description:** With many states adopting medical marijuana laws and the world of CBD (cannabidiol) products literally exploding onto store shelves everywhere, it can get very confusing to understand what is going on and what this means for public health. It's important to understand the differences between these two components of the cannabis plant. This workshop will explore the properties of each, along with information useful for prevention efforts to avoid misinformation on the topic of THC (tetrahydrocannabinol) and CBD products. How the use of CBD products impacts our communities will also be discussed. Dangers associated with both the new THC medical products and the unregulated use of CBD products will be analyzed during this workshop.

#### Learning objectives:

- Attendees will leave with a clear understanding of the differences between CBD and THC derived from the cannabis plant.
- Attendees will appreciate how CBD products are utilized and what makes them different from THC products marketed for medical benefits.
- Attendees will gain an awareness of the adverse effects reported with use of both CBD and THC products.

#### Sequoia Ballroom 3 Suicide Prevention & Drug Prevention: How We Can Work Together to Save Lives Michelle Price, Ohio Suicide Prevention Foundation

**Description:** Suicide is the 10<sup>th</sup> leading cause of death in the United States and the 11<sup>th</sup> cause of death in Ohio. In this workshop, participants will learn about current trends in suicide and drug overdoses in Ohio. Participants will learn the risk and protective factors of suicide and how they are similar and how they are different. We will discuss the importance of collaboration between coalitions addressing substance use/misuse prevention and the efforts of suicide prevention coalitions.

- Attendees will be able to identify emerging trends in suicide and drug overdoses in the state of Ohio.
- Attendees will be able to demonstrate a clear understanding of the importance of suicide prevention and substance use/misuse prevention collaboration.
- Attendees will be able to identify the differences and similarities between suicide and substance use/misuse prevention.

# Sequoia Ballroom 4 Understanding the Prescription Drug Monitoring Program

Tessa Miracle, Interact for Change, Strategic Prevention Framework Rx Consultant

**Description:** Ohio's Prescription Drug Monitoring Program (OARRS) safeguards against overprescribing and increases patient safety. This session will teach participants how to access data, how to interpret data, and use data in strategic planning. We will discuss the relevance of the state and county statistics accessible on the site, while clarifying the terms used in reports. Terms such as morphine equivalent dose (MED), opioid doses, and doctor shoppers will be clarified.

Participants are encouraged to bring current community logic models or strategic plan maps to identify data that will support community efforts. We will work step-by-step to thoroughly review all data Ohio's Rx Drug Monitoring Program has publicly available.

#### Learning Objectives:

- Attendees will be able to access OARRS data.
- Attendees will understand current statewide trends as identified by OARRS data.
- Attendees will understand and learn about the role of OARRS data in community planning.

#### Sequoia Ballroom 5 Vaping & Other Drug Trends

Christi Valentini-Lackner, OCPS, BA, Director of Prevention Action, PreventionFIRST!

**Description:** Stay on top of all the recent trends in substance use and drug overdose. In addition to vaping, there are other current and emerging drug trends that are of public health concern and require attention. This session will focus on current drug trends and the specific evidence based prevention strategies that can address emerging drug trends. Session attendees will learn how to access and analyze emerging trend data, and apply data to strategy selection.

- Attendees will be able to access and analyze data specific to their community's drug trends.
- Attendees will be able to identify trustworthy resources specific to alcohol and other drugs.
- Attendees will learn prevention strategies to address substance misuse.
