#### PRIVACY POLICY

We have developed this Privacy Policy (the "**Privacy Policy**" or "**Policy**") to inform you how COALITION FOR A DRUG-FREE GREATER CINCINNATI, INC. dba PreventionFIRST! ("**Company**" or "**We**"), collect, use, maintain, protect, and disclose information you submit or we collect from you.

Please read this Policy carefully to understand our policies and practices regarding your information and how we will treat it. This Policy may change from time to time (see **Changes to Our Privacy Policy**). In most instances, your continued use of the Company websites located at **www.prevention-first.org** (the "**Website**") after we make changes is deemed to be acceptance of those changes, so please check the Policy periodically for updates.

This Policy applies to information we collect:

- On our Website.
- In email, text, and other electronic messages between you and our Website.
- From any other sources that include links or references to this Policy.

## Children Under the Age of 13

Our Website is not intended for, and should not be accessed or used by, children under 13 years of age. No one under age 13 may provide any personal information to or on the Website. - If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of the Company, our customers, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.

We strive to provide you with choices regarding the personal information you provide to us. We have created mechanisms to provide you with the following control over your information:
